MEMORANDUM OF INTERVIEW BETWEEN M.L. ANDREASEN AND V.T. HOUTEFF December 15, 1942

- M.L. Andreasen called at about one c'clock to see Mr. Houteff to ask certain questions concerning the belief of the Shepherd's Rod people. The interview lasted about three hours, for the most part of which Elder F.D. Wells, President of the Texas Conference, also was present.
- M.L. Andreasen: My name is M.L. Andreasen, from Washington, D.C., a teacher in the Theological Seminary. I asked the privilege of the General Conference Committee to visit with you to ask certain questions concerning your work. If I should ask questions you do not wish to answer, be perfectly free not to do so.
- V.T. Houteff: We have nothing secret here of any kind. You may ask any questions you please, and I shall do the best I can to answer them.
- M.L. Andreasen: You have written two volumes called, I believe, "The Shepherd's Rod." These were written some years ago. It often happens that a man modifies or changes his view, and may wish he had not written what he has. I want to know if your views are still those published in these volumes, or if you have changed your position since they were written?
- V.T. Houteff: I do not work that way. My views now are what they were then.

 There may indeed be certain modifications, or perhaps additions; for we are constantly receiving greater light; but there is no change in the doctrines. The two volumes to which you refer are our belief at the present time.
- M.L. Andreasen: Do you claim that these books were written under inspiration?
- V.T. Houteff: I believe I had definite guidance in writing them. The words are not inspired, but the ideas are.
- M.L. Andreasen: Do you claim to be a prophet or a messenger, or to have any definite revelations?
- V.T. Houteff: I make no claim to be either a prophet or a messenger.
- M.L. Andreasen: There are those who claim and consider you a prophet?
- V.T. Houteff: I am not responsible for what others call me. I like to be called just Brother Houteff.
- M.L. Andreasen: Are you a Seventh-day Adventist?
- V.T. Houteff: Yes, I am a Seventh-day Adventist. I believe the truth the same as you do, both the Bible and the Testimonies.
- M.L. Andreasen: What points, if any, are there in which you differ from the Adventist Denominational belief?

- V.T. Houteff: There are two points. The question of the Six Seals and the Trumpets. I believe that both of these lines of prophecy take in the whole time from creation to the end of the world, and do not merely cover the New Testament period.
- M.L. Andreasen: How about your position in regard to the setting up of the kingdom before the Lord comes?
- V.T. Houteff: In this matter we also differ somewhat from the denominational belief. We believe that the kingdom of the Lord is set up here on the earth before He comes. The Shepherd's Rod people have been raised up to bring a message to the church that will cause a separation of the wheat and the chaff in the church. As a result of this work the hundred and forty-four thousand will be developed. These hundred and forty-four thousand are the first fruits. The second fruits are those who are converted after the hundred and forty-four thousand come out and finish the work in the loud cry.
- M.L. Andreasen: You say you are a Seventh-day Adventist. Are you a member of the church?
- V.T. Houteff: I am not a member of the church. I was put out.
- M.L. Andreasen: You believe in tithe paying. Do the Shepherd's Rod people pay tithe to their own organization?
- V.T. Houteff: Yes, they pay tithe.
- M.L. Andreasen: Are your books open for inspection?
- V.T. Houteff: They are. We have no secrets here.
- M.L. Andreasen: If I asked for a financial statement could I get one?
- V.T. Houteff: You could. I shall see to it that you get one.
- M.L. Andreasen: Are you doing any missionary work in foreign lands?
- V.T. Houteff: We have men there, but they are not paid missionaries.
- M.L. Andreasen: Are the ministers you have in this country paid from the tithe?

- V.T. Houteff: Yes, but they do not receive the wages your ministers do.
- M.L. Andreasen: You have quite a few families living here on Mt. Carmel. Are they paid for the labor they perform?
- V.T. Houteff: Yes, we pay the adult laborers from 14 to 17 cents per hour.
- M.L. Andreasen: Is this paid in United States money?
- V.T. Houteff: We have our own money which we call "trade" money, and which can be used only in buying from our store here. Should any desire to buy things down town, they may be allowed United States currency for that purpose. Not much of this is done, however.

- M.L. Andreasen: Do the workers generally make enough to support themselves and their families?
- V.T. Houteff: That depends on how much they work. This can generally be done.
- M.L. Andreasen: Do the children work also?
- V.T. Houteff: They do.
- W.L. Andreasen: I have noted in one of your booklets a pioture of Zechariah's vision of the two olive trees. In that vision there are two pipes running from the trees to the reservoir. I understand you olaim that one of these pipes is Mrs. White and that you are the other. Is this true?
- V.T. Houteff: It is not true. I make no such claim. There are not only two pipes, but five more, seven in all. If the two pipes of which you speak are prophets, so must the others be. The idea is absurd.
- M.L. Andreasen: I notice that in one of your illustrations you have the beast with names of blasphemy upon the head. You have the different denominations mentioned, and among them the Landicean, or Adventist church. You have also the name of Mrs. White, together with Miller and other reformers, noted on the chart. Do you consider that Wm. Miller and Mrs. White are part of this beast "full of names of blasphemy?"
- And hence are not to be considered as being part of these "names of blasphemy." They were the founders of the First-day Adventist and Seventh-day Adventist churches respectively. These observes belong to the beast, but not the names of the leaders.
- M.L. Andreasen: Are there any other points in which you consider yourself at variance with the doctrines of the Seventh-day Adventist church?
- V.T. Houteff: I do not think of any other.

INTERVIEW CONTINUED - December 16. (Mr. Wells not being present)

- M.L. Andreasen: Are you agreed with the denomination upon the question of the Atonement and Salvation in Christ?
- V.T. Houteff: I know of no difference.
- M.L. Andreasen: Are you carrying on school work here on the grounds?
- V.T. Houteff: We are. We have the ordinary grades, and also an academy.
- M.L. Andreasen: Can a student go from your grade school directly into the public high school? And can they go from your academy into a college? That is, is your school state inspected or recognized as a standard school?

- V.T. Houteff: Our school does standard work, and students may enter from our grade school to the high school, or from our academy to the college.
- M.L. Andreasen: Is there any truth in the reports which I have heard that some of the children here have been punished harshly? Is there any truth in the report that girls have been stripped and lashed until the blood flowed and infection set in; and that others were burned until their fingers blistered?
- There is no truth whatever in these reports. They are malicious rumors. I shall be glad to call in the children and have them tell you the truth.

Mr. V.T. Houteff Mt. Carmel Whoo, Temas

Bear Brother:

The accompanying report is, as you will notice, incomplete. Brother Wells asked certain personal questions which I did not include, first because my report emerges only the questions I saked speeks, and secondly, you did not feel that anything personal should be brought in. Hence I have existed any reference to this. I have also emitted the conversation that emend when Brother Bingham came over, as again I did not originate the subject, now has it may bearing upon what I was after.

If there is snything in the memorahdum that you feel should be stated differently, I wish you would strike out as change such statements so that it conferms with your understanding of the matter. I believe I have oaught the general intent of what you said, but if I have not, be free to change. The report was not taken down stangeraphically, so all we can do in to write down to the best of our recellection. Their free therefore to make such changes as you think; should be made, and if you then feel free to make the night to may do so under my name.

May I be permitted to may that I was very much interested in your preparation; to have me stay and meet with your family. You urged this rather strongly, and Brother Bingham did Alkewise. I should have been glad to do no lend not the people bean waiting suicide for me to take me to the station. I had appointments in Chiahema City which had been out for mouths, so I maild not write. Had I know this the day before when I visited you, I might have arranged to meet with you Tuesday night; but I did not know at that time that you desired such a meeting.

However, I am still interested in year preparities. You rather falt that I neglected an excellent opportunity to do a little missionary work if I did not accept your invitation. You stated that these people are Seventh-day Adventists, and as I doubtless falt they would be lest if they continued in the Shepherd's Rod movement, I should do something to help them. Tou offered to call them together immediately, and I could talk with them, and then you could later, by yourselves, consider that had been said, and weigh the matter.

Do I understand, Brother Houteff, that you would give me the privilege of coming back and speaking to your people one or more times, as you think best? I should be most happy to do so. If you really think I can be of some help to them to show the error in which they are enmeshed, I would be glad to come back sometime to do this. I would not come back for a discussion or a debate. You did not mention this at any time, so I suppose you had in mind giving me the privilege of speaking to the people. I repeat, I shall be glad to do this. You kindly offered to give me room and board. I might not feel free to accept this, but I would be glad to pay for my stay there, or even better yet, I would like to work to pay for my meals. That will give me an opportunity to see just how you live, and to talk with your people separately and alone. I repeat, I am not interested in any debate or discussion, but I am interested in your proposition to come and have some meetings with your people undisturbed and unhindered by you or anyone else. If this is your proposition, let me know, and I shall be glad to arrange my work as soon as possible to come back. If this is not your proposition, please let me know what it is. As stated before, you did not mention any discussion or debate, but invited me to speak to your people. This proposition I accept.

In regard to your statement which I understood you to game made that I was dishenset and had come as a spy, I am willing to accept your statement that you did not believe you said this, but that you put an if in it, that if I had come as a spy I would be dishenset. I would call your attention to the fact that upon my coming I amendiately gave you my name and my position, and said that I had come to get certain information, to which you said that you had no secrets. I did not go around your grounds. I entered just the one building and talked with you. I do not think I could have done otherwise. I went about my business honestly and above board, using no camouflage whatever. I told you several times that if I asked embarrassing questions you need not answer them. I did not at all appreciate your statement concerning the spice and dishonesty, but I do accept your apology.

ly intention in doming was exactly what I stated: I had read your works, and felt that there were so many statements there which I was sure you no longer believed. I maked a statement from you that you were still of the same opinion, or else a definite statement that you no longer believed what you then wrote. I shall use my best judgment how I will use your published writings, but in all that I do'I trust I shall have grace from God to be perfectly homest and above board in all things.

Dear Elder Andreason:

Your December 17 letter, addressed to Brother V. T. Houteff, has come to me for attention, and it is a pleasure to make reply, though I wish I could have been present at the interview on December 15.

Your letter of August 11, addressed to me, indicates that the "research work," which you were doing, was for the purpose of securing "exact and authoritative information concerning the Shepherd's Rod Movement." You also make it plain that you do not want to misquote us, etc., which is very commendable on your part.

Furthermore, in this same letter to me, you call for two things. First, the points upon which we differ from the denomination, as to doctrine, and second, a statement of additional light not known by the denomination, and now being rejected by them. You are well acquainted with the disposition made of the August 11 letter.

Coming now to your recent interview with Brother Houteff, the major portion of which time Elder F. D. Wells was present, I could see no particular objections to most of the questions, if they are proper to ask all other religious organizations, but there are some very leading ones which I consider entirely irrelevant, and which you would not think of asking other organizations. For instance, about the class of work done in the school, and whether or not students can enter other higher schools directly from ours, the punishment meted out to students, etc., etc., etc.

These latter questions, Elder Andreason, I consider are far beneath the dignity of a man occupying the position you hold, and I am wondering if they really originated in your mind. I relish these irrelevant questions perhaps about as much as you would if our cases were reversed. As a matter of fact, you would know no more after we answered them than you do now, for the simple reason that you would be compelled to give as much credence to the one who put the questions in your mind, as you would to our answers.

Nothing would give me more joy this morning than to believe you were an honest inquirer for truth, and that your interview

was for the purpose of ascertaining whether or not this message was indeed one from the Lord to His people, and that you would also accept it, should you find it to be true. On the other hand, if you have already decided that it is error, and if you are only trying to find some fault with the messenger, or the management here at Mt. Carmel, then I shall be very sad, for all the "research" work you would do here, would be with so much bias that not only your time but ours also would be wasted. My prayerful hope is that the former motive actuated you in your visit here.


